

## Amb. Robert O'Brien Joins Signature Resolution

O'Brien previously served in numerous senior government positions, including Special Presidential Envoy for Hostage Affairs. He led negotiations resulting in the return of over 20 American detainees and hostages held overseas and was accorded the personal rank of Ambassador by the President.

O'Brien was awarded the National Security Medal, the National Intelligence Distinguished Service Medal, the Department of Defense Distinguished Public Service Medal and he received the Presidential Medal of Merits from the Government of Kosovo.

He holds a J.D. from the U.C. Berkeley School of Law and his B.A. in political science from UCLA.
